

GENERAL INFORMATION

GROPAK A.I. is a proprietary blend of complex secondary and micronutrients and beneficial mycorrhizae that is intended for use as an inoculant seed lubricant.

DIRECTIONS FOR USE

Always follow directions and precautionary statements on labels. Application should be made in such a way to ensure that all seeds are completely coated. An effective procedure is to fill the hopper box half full of seed and apply one half of the recommended rate of **GROPAK A.I.** seed treatment and stir completely. Fill the seed hopper with the remainder of seed and spread the balance of the recommended dosage of **GROPAK A.I.** over the remaining seed. Stir the balance completely. **GROPAK A.I.** can be mixed with most fungicides and pesticides.

RATES - Applied to seed in hopper box.

Beans (green & dry), Brassica crops, Corn, Cotton, Milo, Grass Seed, Legumes (clover & alfalfa), Sugar Beets, Vegetable and Cole crops: 3-6 oz per unit of seed

Cereal Grains: 3-6 oz per unit of seed

Legumes (vetch, peas): 3-6 oz per unit of seed

Potatoes: 3-6 oz per unit of seed

Rice: 3-6 oz per unit of seed, applied to seed in drill seed box

Soybeans: 3-6 oz per unit of seed

STORAGE AND DISPOSAL

Store in a cool, dry place in original container. DO NOT FREEZE. Keep container tightly closed. Do not reuse empty container. Triple rinse then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state, and federal regulations.
